# **MECHANICAL TIMER**

### WARNINGS:

- The unit is to be connected to a 120V, 60Hz power source only.
- Capacity: 15A, 1875 W Resistive (General Purpose); 10A, 1250 W Tungsten (Lighting).
   Do Not Exceed Capacity.
- Do not attempt to disassemble the unit. There are no serviceable parts inside.
- The timer is for indoor use only.
- PLEASE READ THROUGH THE INSTRUCTIONS BEFORE USING.

## **INSTRUCTIONS:**

- Turn the dial (1) clockwise until the current time lines up with the "Time Mark" (2).
- Rotate the green "ON" tab (3) around the dial to the desired time for the power to be turned ON.
- Rotate the red "OFF" tab (4) around the dial to the desired time for the power to be turned OFF.
- Connect appliance to the timer and plug timer into a wall socket for power source. Turn the appliance on.

#### **ON/OFF SWITCH:**

- Temporary manual override of the programmed times is possible
  by turning the "ON/OFF" dial (5) to the right until the opposite setting is displayed.
  (For example, rotate the "ON/OFF" dial (5) to turn the power to OFF when the timer is programmed to be on.)
- Manual override will not deactivate future programmed actions. (For example, If you turn the power OFF early, the timer will turn ON again at the next programmed setting.)

#### NOTE:

- Program repeats every 24 hours
- Timer is based on a 12 hour timing format. There are AM and PM hours on the dial.

#### WARRANTY
